Permission to enroll in a course in another division is only granted exceptionally. You must obtain authorization from: (1) the faculty or division offering the course; and (2) one of your current Arts & Science programs confirming the course can count towards your program of study. Use this form if:

1. You wish to take an undergraduate course offered by the Faculty of Applied Science & Engineering, the Faculty of Music, or the Faculty of Kinesiology and Physical Education; or
2. You wish to take a graduate course offered by a Department or Unit outside of Arts & Science

You do NOT need to use this form if:

- You wish to take a course at UTM, UTSC, or the John H. Daniels Faculty of Architecture, Landscape, and Design; you may enroll in these courses on ACORN provided you meet enrolment controls established by those divisions. Prerequisite requirements from the relevant division would apply.
- You wish to take a course that is pre-approved for use in an A&S program, for example, MSE (Material Science) courses, or certain MUS/HMU/TMU (Music) courses. Enrol through your College Registrar's Office or on ACORN.
- You wish to take a graduate course offered by an Arts & Science Department or Unit – in which case, use the "Request to Take an Arts & Science Graduate Course" form.
